After the end of the Rescission Period, you can cancel service by using the contact information set forth in the Supplier Information Section above, however, you will be charged the Cancellation / Early Termination Fees and/or Device Cost Recovery Fee set forth above.
<b>RENEWAL TERMS</b>	At the end of your Initial Term with Direct Energy, your agreement may continue on a month-to-month basis and you may pay a variable rate. This variable rate may be higher or lower each monthly billing cycle.
